Annexure A: Why do you need a replacement? Please follow the guidelines as stated in

Explanation of the Fee Structure:

All NFPA/IFSAC certificates issued prior July 2020 was issued with a golden "sticker" IFSAC seal. Each golden seal has a unique seal number registered on an applicant's ID number. Only one (1) seal number, per NFPA Level, is allowed to be registered per person's ID number. Upon application for reprint of NFPA/IFSAC Certificate(s), a new seal must be registered on the applicant's ID number. The applicant's previous seal number will be de-registered and a new seal number be registered on the ID number of the applicant. Since July 2020, all golden IFSAC seals, issued by SAESI, have changed to digital seals, which means that your "new" certificate will not have any "sticker" seals anymore. The applicant will be issued with a digital seal that will have a different seal number than the previously issued "sticker" seal number.

- New certificates must be designed, therefore will an administration fee be charged.
- A new IFSAC seal must be issued, therefore will a fee be charged for a new seal.
